The examination fee prescribed for PG Diploma Course (Annual Scheme) Examinations are as follows:

PG Diploma (Full Examn.Fee) - Rs.2805-00

In addition to the prescribed fee for the Examination, the following amount shall paid by all the candidates irrespective of the caste/category.

Out of scrutiny fee of Rs.10/- College may retain Rs.8/- and Rs.2/- to be credited to the University funds. The retained amount of Rs.8/- by the Colleges shall be utilized towards contingency expenditure including stationery and all other incidental expenses (except answer books and postages).

As per the University Circular No.RPS/Fee/2009, dated 12.11.2009, in respect of University Departments / Constituent Colleges students residing in BBMP area should pay the Examination fees to the University by way of crossed DD only drawn on any Nationalized Bank in favour of the Finance Officer, Bangalore University, Bangalore and payable only at State Bank of Mysore, Nagarabhavi Branch, Bangalore – 560056. This shall be remitted either at the City Finance Office Cellor Floor, Library Building, Central College Campus, Bangalore – 01 or at the Office of the Finance Officer, Ground Floor, Administrative Building, Jnanabharathi, Bangalore-56 and obtain an official receipt for the same. The said receipt issued as proof of payment of amount, shall be enclosed to the intended application compulsorily. Any other form of remittances like Cash, Cheque, IPO, Bank Challans, Money Order, Mail transfer etc., are not accepted.

Under no circumstances the last date for payment of fee and submission of applications will be extended. The Examination fee once paid will not be refunded or re-adjusted under any circumstances.

The Principal of the College is requested to accept the Examination applications only from those candidates whose admissions are approved by the University and send the filled in applications along with the list of candidates arranged 'Alphabetically', subject-wise in triplicate to the University on or before <u>23.08.2017</u>. The candidates should enclose Photo copies of marks card of their previous appearance, if they are repeaters.

The Principal is requested to send the Question paper indent along with one set of candidate list to the confidential section on or before 23.08.2017, failing which, Penal fee of Rs.7000/- will be imposed.

A student has to satisfy a minimum 75% of attendance in each subject out of 90 working days in each year to become eligible to appear for the examination. Those students, who do not satisfy the above mandate, shall not be issued Hall Tickets from the Chairperson of the concerned Department.
